

BIOFA Holzbodenseife weiß (Wooden Floor Soap, white) Art. No. 2092

Properties

BATIM Holzbodenseife weiß is a high-quality, highly concentrated soap combination for cleaning, maintaining and refining soap-treated and lyed surfaces. High solids content, phosphate- and sulphate-free. Suitable for normally stressed softwood floors e.g. in living areas and bedrooms, for wall and ceiling planking, furniture, doors and worktops in kitchens.

Ingredients

Water, 5-15% soy bean oil and coconut oil fatty acid saponified with potash, titanium dioxide, lavandin oil (contains linalool).

Application

Initial basic treatment of merely soap-treated and of lyed surfaces:

Mix wooden floor soap 1:7 with warm water, apply liberally and allow to soak in for approx. 20 min. Then rub in by brush or grinding fleece. Collect excessive soap with a rubber wiper and remove. Repeat this process 2-3 times every 3 hours. A particularly beautiful finish is obtained when polishing the surface with a white pad after each drying process.

Cleaning and maintenance of soap-treated and lyed substrates:

Mix wooden floor soap 1:40 with warm water. Sweep the floor damp, if necessary, scrub or treat with a grinding fleece. Allow to soak in shortly to increase the cleaning effect. Surfaces treated this way become more and more resistant with every treatment. If necessary, repeat the process 2-3-times.

Attention! Store diluted soap cool and use up within 14 days, otherwise stains may form and yellowish discolouring of the wood may occur.

Cleaning of tools

Clean with water immediately after use.

Spreading rate per coat

10-15 m²/l for undiluted wooden floor soap.
1 litre of undiluted wooden floor soap is sufficient for 70-100 m² at a mixing ratio of 1:7.
1 litre of undiluted wooden floor soap is sufficient for 400-600 m² at a mixing ratio of 1:40.

Storage

Cool, dry and sealed airtight.
Protect from frost.

Container size

1 l / 2.5 l / 5 l PE or PP containers.

Safety instructions

Keep out of reach of children. Avoid eye contact. In case of eye contact, thoroughly rinse with water immediately. In case of ingestion, seek medical assistance immediately and show the package or label to medical personnel.

Disposal

Dispose of large amounts of residue according to locally applicable regulations. Small amounts of residue can be emptied into drains.

Completely emptied containers should be disposed of in compliance with local regulations.
